At 7:15 pm, Jordan Thomas, PhD with the University of Missouri gave a presentation on the new Red Choice program, which is a defined heifer development program based off the Show-Me Select Heifer program.

- Their goal is to promote improved heifer development and increase marketing opportunities. Not only is it a marketing tool, but buyers have confidence that these females have been managed to a high standard.
- Wean: Vaccination program, Brucellosis OCV, parasite control
- Pre-Breeding: Vaccination program, trac score, pelvic measure, parasite control
 - o Service Sires must meet a CED requirement.
 - o Pelvic measurements must be greater than 150 cm, if a measurement is less than 150 cm, she can be re-checked at preg check, but must be at 180 at that time.
 - o Breeding records: Preg check within 90 days of start of breeding season
